3.3. New Issues

3.3.1. ISS 0055 - End User letters for Shipperless Sites (Unregistered Sites)

CB enquired about the progress of Transporters issuing End User letters to address Shipperless Sites.

CW aimed to reassured Shippers that Transporters were working very hard to address Shipperles sites. He confirmed work was being undertaken through the Xoserve Shipperless Sites Workgroup, and further data cleansing was required before letters were issued. The next Shipperless Sites Meeting will be held on 05 March 2013.

CW explained that route cause/measures analysis and data cleansing was taking place but Transporters were not intending to write to letters to customers at this point in time, until further data cleansing has been undertaken to ensure Transporters avoid writing to customers who have legitimate contracts.

AJ suggested more frequent industry meetings should be considered to increase momentum and ensure actions are being taken. AJ challenged that the route cause report has been available for quite a while and looked for further progress.

CW reiterated that the Transporters wish to avoid writing letters and potentially upsetting Shipper customers, however CB suggested that this could be easily addressed by the tone of the letter to initiate contact and encourage further interaction.

Transporters assured the Shippers that they would discuss the progress with Xoserve and the way forward, to provide an update. CW acknowledged the concerns expressed today and agreed to provide feedback to the relevant industry forums.

It was agreed to raise an issue relating to Unregistered Sites with a high priority to enable regular Transporter updates at the Distribution Workgroup.
