4 Any Other Business

4.1.1 Legal Text Production

SM expressed his intention to raise a modification regarding the production and provision of legal text. He recognised this would be Governance Modification but suggested discussion in the Distribution Workgroup would be more appropriate as it would allow more time for assessment.

CW was keen to understand the issues around the production of legal text. SM believed a dedicated resource would be more beneficial rather than relying on Transporter resources. He believed a central resource would drive consistency, allow proposers more interaction into the process, and improve quality and impartiality.

SM was keen to receive feedback on how this could be achieved. CW wanted to understand the route cause of the issues to ensure any move towards a central resource would actually address the issues.

The Workgroup considered if a modification would be required and if it would achieve the aim. TD highlighted there would be a required change to UNC text as it currently refers to Transporters producing text, he suggested an option may be to refer production to the Code Administrators.

CWa advised that there was an issue related to this subject being discussed at the Governance Workgroup and he felt it would be the most appropriate forum for the discussion. SM disagreed; as the issue had been raised a number of months ago and no progress had been made. CWa advised that he would discuss the issue with other Transporters with the aim of providing views at the 19 September Governance Workgroup.
