3.3 New Issues

Modification 0428 'Single Meter Supply Points' – (18 month) implementation timeline concerns

GE suggested that from a systematic and commercial impacts perspective, the proposed implementation timeline is acceptable, although there are risks involved. He does not see this as being a simple 'switch it over' approach and believes that there may be need for a process for system de-aggregation to take place followed by an amendment to transportation charges. He suggested that should – he would be seeking to discuss the matter with Transporters in due course.

CB advised that she had also discussed her commercial concerns with Ofgem, especially bearing in mind the potential Project Nexus 'knock on' impacts. She is also worried about the proposed 6 week de-aggregation timeline and whether or not Xoserve would be able to manage the potential (change traffic) volumes involved.

GE moved on to voice his additional concerns relating to potential threshold crossers and competition act impacts when undertaking a 'big bang' implementation. In his view, should the implementation be linked to Project Nexus delivery then he would potentially not disaggregate until the 11th hour. Responding, DA indicated that he does not perceive any system volumetric issues should parties leave their disaggregation's until the last minute. A new action was assigned to Xoserve (DA) to provide a view on the proposed process, disaggregation volumes and threshold crosser timelines and to highlight any potential material impacts associated with the process.
