Update: HC confirmed that some DESC members have suggested that a more robust profile was required rather than billing customers based on a profile created from a single source from a single LDZ and applying this nationally. Shippers are intending to provide Xoserve with at least 12-18 months of pre-payment data to assist with building a more robust profile with a view to creating an 'adjustment factor' to apply against a standard profile to account for weather variations across LDZs. 3.3. New Issues

3.3.1. ISS 0064 - Within Day Meter Read Service Provision

Further to considering Modification 0466 – Daily Meter Reading Simplification and Gazprom's request for National Grid Distribution to provide potential indicative service cost charges for a within day Meter Read service. SM agreed to provide the details of the Supplier's licence condition for National Grid Distribution to review and consider the development of a commercial service to meet the Supplier licence obligations.

3.3.2. Pressure Indicator

AM enquired about the possibility of applying a service pressure indicator flag to sites. He believed this change may have already been considered but not progressed. He suggested the flag would assist meter installations and help prevent medium pressure meter installations having the wrong pressure regulators installed. The workgroup discussed the principal but decided not to raise an issue at this stage.

4. Any Other Business

4.1 Default AQ for siteworks

MJ enquired about default AQs for new SSP sites with larger AQ values. He enquired how defaults AQs are assigned for CSEP NExA sites and what the default value is for DNs. The Workgroup understood that the siteworks connection process evaluates the likely consumption and applicable AQs. It was considered whether the default value table for all new sites should be reviewed.
