DA noted that there was a similar proposal under iGT UNC to use prepayment data but that this did not obligate Transporters and their agent to use the data. CW felt this should be managed through an amendment to the CSEP NExA and that this would require a code modification. CB agreed to review the requirements and participants agreed an issue should be raised with medium priority.
