4 Any Other Business

4.1 UNC TPD Section G7.3.7 - Invoicing Read Estimation Proposal

DA gave a short presentation outlining the background to the proposal to enable correct transportation commodity and energy reconciliation and to fulfil the requirements of UNC TPD Section G7.3.7.

Where the User has not provided a read for the Confirmation Start Date (by 10th business day after Supply Point Registration Date), Xoserve propose to estimate a read for Registration Start Date. The estimation will be based on the Meter Fix date and the AQ. This should enable transportation charges to be calculated for the preconfirmation period and correct reconciliation for LSPs to take place, facilitating correct energy and commodity reconciliation. Accurate reconciliation of these charges will reduce the level of unidentified gas and apportion charges correctly.

To progress this proposal Xoserve needs to determine if a read at Registration Start Date can be estimated and is carrying out further analysis.

No comments had been received from the Workgroup following requests made at previous meetings, therefore Xoserve will assume that it is agreed for it to proceed on the proposed basis.

DA will confirm implementation timescales to the Workgroup when known.

4.2 Modification 0431S – Shipper/Transporter – Meter Point Portfolio Reconciliation

DM reported that a request had been received to amend this modification to increase the number of Business Days from 25 to 40 to enable a Shipper to register each MPRN. The Proposer had acceded to this request and amended the modification. Shippers found this to be extremely helpful.

It was agreed it was not a material change and could be reflected in the Workgroup Report, and that no further Workgroup meetings need be arranged.
