1. Introduction and Status Review

BF welcomed all to the meeting.

1.1. Approval of Minutes (23 February 2017)

3. Project Nexus Requirements

3.1. RAASP

Introducing this item, BF explained that the Workgroup has the right to defer consideration of this late submission – the Workgroup agreed to consider the matter at short notice.

DA provided a very brief overview of the supporting presentation explaining that in future (post FGO/DSC/Nexus world) Xoserve would be working very closely with Change Managers to progress matters.

During a brief discussion, it was noted that RAASP would be considered in more detail as part of the Change Management Committee discussions, especially when considering the change prioritisation aspects.

When asked, CW confirmed that following discussions on the matter with Ofgem he does not anticipate raising a formal UNC modification at this time and is awaiting further clarity around the proposed October 2018 date before committing to a modification. DA added that delivery of RAASP is also heavily dependent upon the successful delivery of Project Nexus and subsequent feedback from Change Managers.

It was agreed to consider the presentation in more detail at the April Distribution Workgroup meeting.

3.2. Transition Business Rules for Project Nexus

DA explained that the document has been amended to take into account UNC Modification 0609 requirements. (*Ref: paragraph 7.6 AQ Appeals amendment on page 18*)

When asked, AC explained that in short, the document is 'catching up' with the 0609 legal text.

4. Issues

5. Review of Outstanding Actions

DX1102: Use of weighted SOQ rather than actual SOQ - Issue arising from Market Trials - DA to provide an interpretation paper to aid understanding, for the next DWG meeting (22 December 2016).

Update: In introducing the 'Workaround – Defect 12790' document, DA explained the issue around the potential BRD omission. In short, the proposed workaround solution adopts a weighted average based approach and has the support of the Market Trials Group. Going forwards, the approach would become the enduring solution.

DA went on to explain that this matter also impacts the Uniform Network Code Validation Rules and therefore, a change marked version of the document has been provided for parties to review and provide feedback.

When asked, DA confirmed that so far, no other Workgroups or industry forums have been engaged on this matter. CB voiced her concern that as it ultimately proposes an enduring solution, explaining that she would be unhappy for the matter to only be discussed and progressed through the Uniform Network Code Committee route.

BF suggested, and parties agreed that this is not really a Distribution Workgroup matter and would really be better progressed through the (new) DSC Change Management review and decision process. CB requested that as there are potential Shipper system impacts involved that Xoserve consider issuing an industry communication to industry wide distribution listings, not least the old UKLC listing. RH also explained the accession approach to the new Change Management Distribution listing creation.

New Action DX0303: *Reference Uniform Network Code Validation Rules amendments* – Xoserve (DA/RH) to issue an industry wide Shipper/User impact communication via the new Change Management distribution listing.

Thereafter, it was agreed that action DX1102 could now be closed. Closed

DX0201: *Reference Potential RAASP Delivery* – All parties to consider providing views to NGGDL (CW) on a potential approach to the system solution delivery concerns in order that NGGDL can respond accordingly at the March Workgroup meeting.

Update: Awaiting further clarification. Carried Forward

DX0301: *Transferred in from 0609WG* – Ofgem (JD) to consider the AQ file validation issue as part of the Project Nexus implementation group and provide a view on options; validate AQ values or introduce a more robust Nexus acceptance process.

Update: CW explained that this matter has also been discussed at a recent PNSG meeting where parties indicated that they are happy with the proposals. **Carried Forward**

DX0302: Transferred in from the final standalone UKLC meeting – Reference COR3143 – File Transfer Guide V12FA V12.1FA – Xoserve (DA) to look to provide a high level process flow map for the Supplier / MAM (non UKL user to non UKL user) aspects and to also consider a suitable publishing location for any supporting documentation.

Update: DA explained that once the various UNC Modification 0613S UK Link Manual related documentation are provided, the action could be closed. **Carried Forward**
