Update: DA confirmed that this was on the agenda for discussion at Project Nexus Workgroup (PNUNC) as it was a UK Link issue. He advised that the preferred option would be for the UK Link programme to allow the Network Proposer I.D. to be amended by the Shipper where currently it is deleted and a new MPRN/ID is requested.

Some workgroup participants were unhappy with this and a number of concerns were put forward as certain bands of MPRNs are ring-fenced to iGTs so it is not appropriate to transfer one of these to a larger transporter portfolio as it impacts charges etc. DA agreed to feed these back to the UK Link Team for further consideration at the next meeting and at PNUNC. **Carried Forward.**

0801: Transporters to consider and respond on whether to standardise the warrant letter for Modification 0478 - Filling the gap for SOQ reductions below BSSOQ until Project Nexus.

Update: DA confirmed that Xoserve had provided a template letter on behalf of the DN's **Closed**

0901: 0516 - Transporters to provide a view on the potential use of customer site characteristic data within an emergency situation.

Update: Transferred to Workgroup 0516. Closed.
