3. Issues

3.1. ISS 0052 - Transfer of Assets

This item is on hold until Transporters and Ofgem have produced a lessons learnt document for presentation to the Workgroup. Some concerns voiced around the delay in producing the documentation as it is nearing 6 months since the issue was raised.

3.2. ISS 0054 - Site Re-aggregation

In accordance with discussions on outstanding Action 0102 above, it was agreed to close this issue.

3.3. ISS 0055 - Unregistered Sites

BF explained that the work behind this issue had now been completed and as a consequence, it was agreed to close the issue.

3.4. New Issues

3.4.1 Modification 0403 – 21 day switching: file processes

DA provided a brief overview of the rationale behind the proposed draft 'Modification – Confirmation Processing on Business Days following non Business Days' and the outcome of discussions undertaken at the 14 February 2013 UKLink Committee meeting.

Focusing attention on the 'Further Example Timeline' table presented in Appendix A, DA explained that whilst it may seem that a complex solution is proposed, it could easily be catered for within (future) system developments.

GE explained that whilst he is happy with the basic concept, he remains concerned about 21 day switching and EU 3rd Party package impacts and considerations. As far as the output of the recent UKLC meeting is concerned, he remains of the opinion that there may be benefit in seeking a view from the Authority – it was noted that the current system provision does not recognise the concept of 'downtime'. In recognising GE's concerns, SM also suggested that this draft modification is really aimed at rare occurrences and it is his worry that it becomes the norm. DA pointed out that there

are also concerns about the system being able to handle and successfully process (bulk) confirmation files that all land on a Monday morning.

Additional concerns around whether or not the modification actually provides for a mechanism to cater for instances where Xoserve identify parties that are not following their 'normal' working pattern / practises – i.e. deliberate or accidental abuse of the system.

Whilst AM advised that he is awaiting his colleagues view on the proposal before formally committing to the (draft) modification, GE remained unconvinced of the merits of the modification.

In the end a consensus view from the Workgroup could not be reached and therefore DA would report this back to the UKLink Committee in due course.¹
