#### 3. Issues

#### 3.1. ISS 0018, Handling of Emergency Situations at Priority Customer Sites

AG questioned the existing emergency contact arrangements to enable the repair or replacement of larger faulty meters outside normal working hours. He explained where a meter is found faulty through an emergency situation a supplier will be contacted to approve the repair and contact their MAM – permission is rarely withheld. Typically the repair is undertaken by the same engineer who visited the site and identified the fault – why can't the emergency service contact the MAM directly and where appropriate undertake the repair at their direction.

New Action Dis0101: ISS0018 - Transporters to consider changing the emergency contact process to allow direct contact with MAMs to seek authorisation to repair a meter where appropriate.

# 3.3. ISS 0029 - Communication of CO Poisoning Incidents

Action update:

**Dis0901:** Transporters to:

- Provide an end-to-end overview of the Transporters' Incident Procedure
- Clarify Transporters' expectations of what actions/responses Shippers must take/make in response to communications received
- Consider appropriate testing of the communication process with Shippers **Update:** EM confirmed that Transporters are in the process of updating the Shipper communication documentation, which should cover all these actions.

#### 3.6. New Issues

# 3.6.1.ISS 0038 - Extension of the DMV regime

SM introduced the issue and explained that the timed removal of DMV through the implementation of Modification 0345 - Removal of Daily Metered voluntary regime on 01 October 2013. He hoped that the removal of DMV could be put in alignment with Project Nexus delivery. SM wanted to ensure the DMV service was not removed prior to a suitable alternative being in place such Product 2 defined in project Nexus. He believed that DME was not a suitable alternative as it currently stands and felt there were two options to be considered:

- 1. Remove the DMV service in line with Project Nexus delivery; or
- 2. Amend DME to ensure it meets customer requirements i.e. Project Nexus Product 2.

New Action Dis 0102: ISS038 - Gazprom to provide a view on the potential amendment to the DME process to mirror Project Nexus Product 2.

#### 4. Any Other Business

#### 4.1 Update on Mod 0279 services and Mod 0353 services

DA provided an update on Modifications 0279 - Improving the availability of meter read history and asset information and 0353 - Population and Maintenance of the Market Sector Code within the Supply Point Register.

He confirmed that the service request form for the 0279 services is now available at

He also explained that the next shipper portfolio for blank market sector codes will be prepared and issued in early February 0353.
