Update: DA provided a brief presentation illustrating the process for adjustment requests. He explained the charge recalculation process and the checks that are undertaken. The proposed modification will state that there are no requirements on Xoserve to validate the information provided by Shippers. He wished to understand other parties expectations in terms of required validation. The presentation highlighted that Xoserve performs a number of validation activities currently, any extension of the potential period that Xoserve may be required to validate might have significant impacts to UK Link and non UK Link systems. **Complete**

JF raised a new issue on the potential data requirements for the implementation of the DECC Smart Metering Implementation Plan. She provided a presentation and suggested that parties will need to start thinking about the issue and the system impacts. Once the system impacts are identified, there will be a need to raise UNC and SPAA modifications to mandate file format changes.

JF confirmed that the governance will be managed through the DECC programme. It was agreed to raise an issue to keep track on the progress of the issue, with a medium level.
