#### 1.0 Introduction

LJ welcomed all to the meeting and reminded that 'Chatham House Rules' were to apply to general discussion.

#### 1.1 Review of Minutes (14 April 2015)

The minutes of the previous meeting were approved.

#### 2.0 Update from (PA/M)

PwC provided an overview of their recommendations, together with the evidence and findings gained to date from 27 organisations within the industry.

It was stated that 4 organisations had decided not to respond as they felt Nexus would have little impact on their operating processes. PwC believed that, from the comprehensive evidence supplied by the specific organisations involved, there is insufficient time to undertake effective Market Trials due to the level of parallel activity and lack of a clear cut off after each organisation's own internal system trials.

Members discussed the reasons for these organisations not being ready in time for the 'Go Live' date and the potential impact on the Programme Plan. PwC explained that the majority of the organisations stated that they do have sufficient time or the required resources to manage the 'cut off' between market testing and their own internal testing, and so would not have completed their internal testing prior to 'Go Live' with the market trials. However, they are going to continue in earnest on their internal trials ready for 01 October 2015. Ofgem stated that it was critical and essential for all parties to continue without losing focus or momentum. PwC then recommended that, due to this evidence and the high level of associated risk involved, it would preferable for the organisations to continue with internal trials and testing, to then conduct the market trials at a later date, with enhanced governance and entry criteria.

Prompted by the Chair as to whether there were any alternatives to such a deferral, Members debated the idea of potentially allowing two organisations to 'Go Live' with the market trials on 01 October in a controlled manner to test the concept. After debate about how realistic this might be in terms of transaction volumes and types, it was deemed this would not be appropriate, nor seen as a positive signal to the industry.

In consideration of the recommendation from the Project Assurance Manager (PwC), the Steering Group agreed that it is fully committed to entering Market Trials by 01 October 2015 (or earlier) and will examine how such trials should then be conducted to establish the earliest appropriate go-live date. This is subject to confirmation following detailed consideration by Xoserve and the PN Project Assurance Manager

Xoserve was asked for an initial view on the impact for them if the market trials were delayed. Xoserve stated that L1 Connectivity Testing was being commenced on Tuesday 05 May, as it was now too late to stop this. The following week File Testing is scheduled, the week after Market Testing was due to start and so Xoserve would need to consider the impacts in more detail, though it was likely that the trials would be suspended at some appropriate point in light of earlier Steering Group discussions. Xoserve also commented that no plans had been discussed presently to re-include Retrospective Adjustments and Unique Sites for October.

The Steering Group requested that:

- Xoserve identify the earliest date/s at which the full functionality, including all necessary User Acceptance Testing, would be available to enter Market Trials, noting that this should be no later than October 2015; and,
- PwC to develop, with industry support, an optimum Market Trials phase that will inform decisions on the revised Go-Live date.

**New Action SG05**: Xoserve to provide a date for a Core functionality, with UAT, Package for Market Trials together with potential phased dates for Retrospective Adjustments and Unique Sites.

**New Action SG06**: PwC to produce an optimum solution for Market Trials along with a recommendation for Go Live, focusing on governance timings and entry criteria with associated impacts.

Looking at the wider effects of a deferral, Members agreed that the following areas should be considered and discussed at the meeting on 02 June 2015.

## 1. Impacts on Modifications 0531/0536/0537 – what is the broader impact on these Modifications regarding the proposed 'Go Live' date change?

Members believed that these modifications should be now treated in the normal manner (ie 'not urgent') and their timelines should align with the Steering Group. The Chair agreed to report this to the Extraordinary Panel meeting due later in the day for Panel consideration.
