# 2. Significant Measurement Error Update

# 2.1. SC006 Aberdeen MTA

The Workgroup considered British Gas' comments on the Significant Measurement Error Summary Report and the responses provided by the ITEs. JK asked the ITEs to acknowledge that there were of high level of uncertainties in the analysis. BK and KV did agree there were on occasion high-level uncertainties and data was difficult to replicate at particular flow rates. He explained that a number of tests were undertaken at different flow rates and that they had worked with all the data that was available.

The Workgroup reached a unanimous view that the SMER process followed was in accordance with the guidelines and that it was appropriate for the report to proceed to the next stage. The Summary and Individual reports were considered finalised.
