1. Introduction and Status Review

1.1 Review of minutes

The minutes of the previous meeting were accepted.

1.2 Review of actions

OF0101: SC012 - SGN to investigate and obtain evidence to test accuracy of meter and the potential duration of the error.

Update: DM confirmed that SGN has investigated their records and cannot find any reference to an installation or calibration date for the meter pre-network sales. He also reported that National Grid Distribution have also not been able to identify any additional information. DM advised that National Grid NTS were still reviewing their records. The Workgroup believed if SGN should establish the date for last calibration, and considered the normal schedule for calibrations this may assist with understanding the likely calibration pattern. CB suggested the manufacturer of the meter have a record of its last calibration or manufacture date. CB enquired if the error was to be calculated in its entirety before considering the line in the sand impacts. TC believed the only real difference in the calculation should be if this were deemed a constant error throughout the error period or not. If there was some derivation usually the error is quantified and then halved which would have a different result. DM believed that having exhausted

various avenues for more data he was uncertain if any further investigation would secure the information the Workgroup desired. **Carried Forward**

OF0102: SC012 - AC and HC to investigate if National Grid NTS and Distribution can provide any information.

Update: AC and HC confirmed they had not able to provide any additional information however further investigations were being undertaken with National Grid NTS. **Closed.**

6 Any Other Business

6.1 WM014 – Atherstone MRA

AC introduced Measurement Error WM014, which had recently been re-estimated to more than 50GWhs. AC explained that this was an inter-LDZ error between East Midlands and West Midlands, it was expected that an adjustment would be required for RbD but not for Shrinkage. The error had resulted in more flow into West Midlands than should have. The estimated quantity of error is 131.9 GWhs.

AC explained that more information would be provided when it was available and an update will be presented on 26 March.
