164.4 Consider New, Urgent Modification

a) Modification 0513 - UK Link Programme (Project Nexus) - independent project assurance for Users

The Chair introduced the meeting, explaining that members had been asked for views on the proposed Urgent status and whether the proposed timeline is realistic. CW explained that he raised the modification as soon as he was aware of the requirements following a tri-way discussion between Ofgem, Xoserve and National Grid Distribution.

Several concerns were voiced around aspects such as the tight timelines proposed (inc. potential materiality impacts), whether or not the modification is focusing on industry compliance with Code rather than industry simply being ready for Project Nexus go-live date and whether or not the proposed User Pays funding arrangements are appropriate.

When asked, AMi provided a brief explanation behind the proposed 12 September 2014 target decision date and its relationship to the publication of a (Baringa Partners LLP) report by 01 December 2014 (which should coincide with the completion of the Project Nexus design phase(s)) – in essence it is a suitable 'check point' before the proposed 01 October 2015 go-live date.

Some parties believe that as this is potentially a contentious matter, there is a possibility that an alternate (urgent) modification could be raised as more detailed consideration of the modification is undertaken in due course.

When asked what the anticipated outputs and subsequent actions from the modification are, JD indicated that at this stage he does not have a clear view on these but that he sees this modification as one piece of a larger jigsaw and that it should / could run parallel to the ongoing Project Nexus development work.

Members then voted and unanimously determined to recommend that Modification 0513 should follow urgent procedures.
