#### 1.0 Introduction and Review of Minutes

LJ welcomed all to the meeting; quoracy was confirmed.

#### 3.0 Matters for Consideration

# 3.1. Consider Legal Opinion in respect of Issue 1.06 and determine an appropriate way forward

Legal Opinion was provided by PwC and this was considered by the PNSG. The validity of the approach was confirmed and the PNSG agreed unanimously to proceed with the approach as planned.

PwC will confirm what information may be published.

#### 4.0 Key Milestones Approval to Proceed

#### 4.1 Industry/Xoserve testing complete for L2 MT (01 October 2015)

AS gave an update on the position, indicating that the majority of parties had made good progress towards readiness.

Two areas required further investigation/impact analysis (reversal of ERR file rejection functionality and uncertainty relating to delivery date of 10 iGT file formats not in the July 'baseline' for L2 MT) to ascertain any consequences for Market Trials.

SS reported that Xoserve was confident of being ready to commence L2 MT and gave an update on the various areas. The ERR files issue was discussed. SS explained the workaround agreed through the MTWG in respect of 'incorrect' ERR that is to be used until 10 December 2016, when the correct ERR file is expected to be available. Responding to a question from a Shipper constituent representative, SS confirmed she was not aware of any issues relating to invoicing files (unless they are August changes that were not in the baseline). SS explained in more detail the technical issues surrounding the ERR file; the issue will not impact the start or end of L2 MT.

The iGT files issue was discussed; it was an issue for some iGTs but they are not in the baseline (August file formats). Options were being discussed at MTWG, but it was likely that they would be included in L3 MT rather than L2 MT, as Xoserve cannot deliver for L2 MT. The impacts on L3/L4 MTs were being assessed by MTWG and confirmation of the workarounds agreed together with a summary position of industry readiness will be provided to PNSG by PwC at least one week in advance of the start of L2 MT.

Action 1001: PwC to provide to PNSG, at least one week in advance of the start of L2 MT, confirmation of the workarounds agreed for the ERR and iGT issues together with a summary position of industry readiness.

A Shipper constituent representative commented on the inclusion of Traders within the analysis, as these generally have no physical Supply Point portfolio. It was observed these parties may have a Shipper account, and might expect to be included if there was any intent for them to acquire a portfolio before Nexus go-live. AS would confirm whether any such parties should be excluded/included within the analysis data (and assigned to a constituency if appropriate).

Action 1002: PwC to ascertain the identities of Trader organisations currently included in the data analysis, whether they have intention having an active Supply Point portfolio prior to Nexus go-live, and establish whether they should continue to be included or excluded from these assessments (and assigned to a constituency).

AS affirmed that PwC would be doing a 'sweep up' exercise to contact parties who had yet to provide assessment/evidence, and would contact constituency representatives if assistance was required to obtain the relevant information.

Attention was then drawn to the recommendation. PwC recommended that provisional approval be given to start L2 MT on 02 November 2015, subject to the completion of the two summary position papers (ERR and iGT files). This information would provide evidence for the final go/no go decision to enter L2 MT. After a brief discussion provisional approval to proceed was given unanimously, with a formal confirmation of approval anticipated (following assessment of evidence) at an interim teleconference meeting - 'a checkpoint call' - to be arranged for Monday 26 October 2015. PwC were requested to provide the necessary meeting papers by the afternoon of Thursday 22 October 2015 to give parties an opportunity to review in advance of the meeting.

AS encouraged the constituency representatives to remind their constituents to update their individual self-assessments for L2 MT, and also to respond to the L3/L4 questions on the PwC portal (a low response had been observed to date).

#### 4.2 L3/L4 MT Approach Approved (14 October 2015)

AS reported this had been debated at MTWG; the document was now out for wider approval (to be provided by Monday 19 October 2015) and to be reviewed at the next MTWG on 21 October 2015.

PNSG unanimously agreed to move the milestone 'L3/L4 MT Approach Approved' to 02 November 2015 and reschedule consideration/approval to its meeting on 02 November 2015.

#### 4.3 Data Cut Taken (12 October 2015)

SS affirmed that the data cut was on track to be taken by the end of today.

The milestone will be reviewed at the checkpoint meeting on 26 October 2015 to confirm that it has been passed successfully.

#### 4.4 Industry Plan - next milestones

Looking at the Plan, LJ drew attention to the next set of milestones:

- 02 November 2015 Start of L2 MT
- End November SAP detailed design.

SS observed that SAP were already in and working through the design with Xoserve. It was suggested that the revised plan for developing RAASP could be reviewed at the November PNSG meeting.

#### 5.0 Programme Risks and Issues

The Risks and Issues Register had been revised to reflect the comments and suggestions made at the previous meeting. The review of the Issues Register entries continued, with each item considered individually.

#### 5.1 Issues

Issues I.04 - I.11 (Proximity and Impact Ratings, and Resolution Actions) were reviewed. Ratings were discussed and assessed and readjusted to reflect current circumstances. Appropriate Resolution Actions were considered in respect of each Issue, and a number of clarifications, revisions, refinements and additions were suggested.

Following discussion, Issue I.04 was converted to a Risk and Issues I.05 and I.10 were agreed closed. Issue I.11 appeared to be poorly formulated and required much more clarity before the PNSG could properly consider, and LJ reminded that any identified risks and issues should be closely scrutinised and properly defined before formal inclusion on the Register and consideration by the PNSG.

AS and GW noted the revisions required; the changes will be made and the Risks and Issues Register will be updated and published on the portal.

#### 5.2 Next Review

It was suggested that the entries on the Risks and Issues Register be reviewed by exception (Red status) at the second meeting of each month (teleconference). Some

constituent representatives suggested that Issue I.09 might require reviewing on a more frequent basis.

The next review of risks and issues will take place at the teleconference on Monday 16 November 2015 (10:00 - 12:00).

#### 6.0 Any Other Business

#### 6.1 MTWG Terms of Reference (ToR)

A Shipper constituent representative had received questions from constituents that queried if there was to be an 'afterlife' for the MTWG following completion of the L3/L4 MT work, and should there be a group that was tasked to deal with any issues that subsequently arose from the MTs?

AS explained the MTWG's role under the current ToR, and a discussion ensued. LJ clarified it was the MTWG's role to set the Approach. Only if the Approach were subsequently proved to be ineffective would the MTWG then be reconvened by PNSG.

**Post Meeting Note:** Draft ToR for the role of the MTWG during the Market Trials, originally tabled on 28 September but not considered due to time, has been circulated to PNSG members on 13 October for consideration/approval.

#### 6.2 Communication Gap - Programme Manager Level

Noting there were a number of different communication routes/levels, another Shipper constituent representative commented there seemed to be a gap between information delivered at the PNSG level and that delivered at a much lower and more technical level, and suggested there may be a need for a 'Programme Managers' forum/regular call to address this.

GW suggested that PwC could develop a short Engagement Survey (3 questions, self certifying), potentially for issue after the start of L2 MT.

Action 1003: PwC to develop a short Engagement Survey (3 questions, self certifying), for PNSG to consider, potentially for issue after the start of L2 MT.
