A DN meeting will now follow to look more closely at the content of the report with a view to providing an

the April meeting.

RM summarised the need to consider which leakage model should be used either the current approved version 1.3 or version 1.4 for this year's shrinkage estimation. He explained that the DNs are neutral to which version to utilise. However RM suggested that there could be a £2.6m adjustment for SSP Shippers made through the Neutrality Invoice if version 1.3 of the leakage model is used. National Grid's view was to utilise version 1.4 methodology for undertaking the end of year assessments, to ensure charges are as close as possible and to avoid an associated adjustment. SA proposed moving to version 1.4 asap for utilisation in calculating the end of March shrinkage volumes, prior to formal approval, to use it for the formal leakage returns at a later date, It was observed if version 1.4 is approved Ofgem would need to reset the baseline incentives

It was agreed to use version 1.4 for 2014/15 year based on version 1.4 offering a better representation of leakage and shrinkage than version 1.3.

SA explained that since the last meeting he had engaged with Ofgem (and published an email for reference). Supporting analysis has been provided. To date there were no new issues further to the two previously raised. However NGN and WWU would clarify the need to reconsult on the methodology.

GL Noble Denton (GL) have confirmed that they have no issues relating to the Northern Gas Networks validation. SE confirmed that he expects GL would now look at the Wales & West Utilities validation.

Action 0202: NGN and WWU to clarify the need to reconsult on the methodology.

Action 0203: DNs to consider their position and if necessary follow discussions with Ofgem and provide a joint DN update report.

Action 0204: Shippers to confirm that their respective concerns have been suitably addressed.

RH and CB suggested that there would be benefit providing the Low Pressure Service Modification Proposal Variance Analysis at a sub-network level as they believed that a 1% variance would constitute a material impact. RM agreed to look at how to best provide sub-network level analysis, including identification of negative values and an assessment of the magnitude of any potential differences.

Action 0205: National Grid Distribution (RM) to look at how to best provide sub-network level analysis as per the WWU analysis (including identification of negative values and an assessment of the magnitude of any potential differences), subject to GL verification of the WWU approach.

Role Change for Rochelle Harrison

RH advised that she is changing roles within British Gas and either Andrew Margan, Graham Wood or Steve Bagnall will attend future Shrinkage Forums

Wales & West Utilities Regulation Management Discussions with Ofgem

SE advised that WWU had been in discussion with Ofgem regarding the potential Smart Metering impact on shrinkage.

He anticipates that the subsequent smart metering report, which will be provided following a consultation with Shippers, will be of limited scope for 2014/2015 reports. RH asked if DNs could provide more granularity around the number of Smart Meters involved and their potential impact.
