TD welcomed attendees to the meeting.

1.1 Review of Minutes and Actions of Previous Meeting (07 July 2011)

1.1.1 Review of Minutes

1.1.2 Review of Outstanding Actions

Action TR 0602: National Grid NTS (MW) to provide a timeline to achieve implementation of 0352 by 01 October 2011.

Update: FH advised that the timeline is still being considered. TD suggested that, as the Modification has been issued to Consultation, there was no reason to keep this action open. **Closed**

Action TR 0603: National Grid NTS (MW) to provide an amended Modification 0352 in time for preparation of a Workgroup Report for discussion on 07 July.

Update: TD advised an amended Modification was provided after the report had been issued to Panel and there was no reason to keep this action open. **Closed**

Action TR0701: 0338 - Provide an ACS for submission to Panel (to the Joint Office by Wednesday 13 July 2011).

Update: TD advised the Panel had referred the modification back to the Workgroup for further assessment of the issues. He recommended that all the actions for this Modification should be closed and issues identified when the report was reviewed. **Closed**

Action TR0702: 0338 - Establish appropriate timescales to allow for changes to be made to the NCORM, and review as necessary.

Update: SP advised that National Grid NTS do not consider an amendments to NCORM is required **Closed.**

Action TR0703: 0338 – Revise/expand the legal text and amend Modification.

Action TR0704: Convene a Transmissions Issues Group (in August) to conduct a review of System Alerts.

Of specific note were:

0349 –LH advised that a number of issues were identified with the text which need clarifying before any decision is issued.

0353 – TD advised that the modification had been implemented.

1.3 Industry Updates

LH reported on recent Ofgem activities:

- CEER's Gas Target Model On 2 August Ofgem published an 'Invitation and agenda to a workshop on the Council of European Energy Regulators' (CEER) Gas Target Model'. The workshop will take place in the afternoon of 1 September and will include a presentation of CEER's vision for a European Gas Target Model and break-out discussion groups to allow stakeholders to express their views. The meeting may be moved to Elexon, in order to follow the Transmission Workgroup.
- TPCR4 rollover Initial Proposals published on 2 August. The
 consultation sets out initial proposals for the year 2012/13 on all
 elements of the price control for the three electricity transmission owners
 and the one gas transmission owner. Consultation closes on 12
 September.
- RIIO-T1 Ofgem has received business plans from each of the three electricity transmission owners and the one gas transmission owner. A non confidential version of each business plan is available on each company's website. Ofgem will review the business plan submission

and publish a consultation in 2011. Ofgem will publish a decision towards the end of October setting out next steps, including which companies, if any, they consider should be fast-tracked.

- Gas Security of Supply Significant Code Review Update letter published on 7 July. Letter explains that Ofgem are planning to publish the draft decision in autumn 2011. This will be followed by further stakeholder workshops and seminars before coming to a final decision. Indicative timing for publishing the final decision is spring 2012.
- Project TransmiT Technical Workgroup meetings began on 19 July and will run every week for six weeks. Second stakeholder meeting scheduled for 18 August.
- Proposed disposal of part of National Transmission System (NTS) for Carbon Capture and Storage. Decision due in September.

RF asked if the links to Transporter business plans could be circulated for each Transporter, or if they could be published on the Joint Office website.

New Action TR0801: Transporters to provide links to business plans for circulation or publication to the industry.

1.4 European Developments

1.4.1 European Gas Codes Update

PH provided an update on the recent workshops advising the presentations had been published for information on the Joint Office website www.gasgovernance.co.uk/tx/040811.

Moffat

PH advised that Moffat is a prime candidate for an exemption from the requirements to have two-way flow capability on all interconnectors. A market assessment is going to take place to identify if there is likely to be an oversupply of Irish gas capability. Since this is not likely there is a case for exemption.

TD asked why the TSO is undertaking the assessment - shouldn't it be the asset owner? NR advised that she understood member states have the obligation to do the assessment and this obligation has been passed on to transporters.

EU Gas Quality Harmonisation consultation

Implementation on 01 October 2011 is planned, but with full implementation in to Gemini screens flowing through around 16 October 2011.
