**115.3 Minutes and Actions from the previous meeting**

**115.5 AUGS Process Update**

a) AUGS's response to Queries on the AUGS

CWh presented the recent queries received from British Gas and the AUGS's response and recommendations for each.

Query 6 – iGT CSEP snapshot

Recommendation - nearest classification is under 8.5 "Material change that can be implemented for final gas volumes and rates" – it does not require a change to the AUGS

Members determined unanimously in favour of the recommendation.

Query 7 – Permanent and Temporary UG

Recommendation - no action.

Members determined unanimously in favour of the recommendation.

Query 8 – Concerns the inclusion of very large AQ's in unregistered site calculations and skewing of temporary UG estimates

Recommendation - Part A of query – Material change but does not require change to AUGS

Recommendation - Part B of query – Material change that requires change to AUGS but that this cannot be carried due to conflicts between the UNC and AUG Guidelines.

Members determined unanimously in favour of the recommendation.

Query 9 – partially consuming iGT CSEPS and that an adjustment should be applied as per the wider population

Recommendation - no action required.

Members determined unanimously in favour of the recommendation.

CWh advised that the table for the Transporters is to be finalised and provided early in the New Year. FC confirmed that it is likely a vote will be requested at the January UNCC meeting seeking not to disapprove the table.
