#### 1. Introduction and Explanation of Workgroup Operation

SE gave a brief presentation outlining the background and intent of the modification, and the proposed timetable.

#### 3. Discussion

RM pointed out that Ofgem had not reached a conclusion as to whether it had the powers to act as the Appeals body within this process.

SL observed that there was an Expert dispute process already in existence under UNC GTA, which might be considered. SE responded that GasTerra's deliberations had concluded that, in its opinion, Ofgem was the most appropriate body to fulfil this position. SL agreed that Ofgem would be the first choice, but suggested that, in the event that Ofgem must decline the role, then UNC GTA might offer an alternative.

### 4. Consider Terms of Reference

The Workgroup considered the Terms of Reference. TD drew attention to the listed topics, some of which had already received consideration within the earlier presentation.

The Terms of Reference were then accepted and approved.

It was agreed that development of the Workgroup Report would be commenced and a draft Workgroup Report would be published for review and comment in advance of the next meeting. The intention would be to complete the Report at the next meeting.
