TD reported that the Modification Panel had accepted the Workgroup's recommendation that Modification 0373 be returned to the Workgroup for further assessment. The Workgroup must make a further report to the Panel by 19 January 2012.

RF then gave an update on progress made. E.ON and National Grid NTS have been working together on the potential redraft of 0373 (and legal text) and intend continuing discussions during November - no major structural changes to the modification are planned. RF had been comparing details with the CUSC and National Grid NTS was reviewing the Application Form to see what other information might usefully be requested and included. He sought the group's views on what technical information a Shipper would want from an Offer, and encouraged attendees to discuss with colleagues and feedback any suggestions on technical requirements to him as soon as possible. These were briefly discussed. RF was also intending to highlight this at an AEP Workgroup.

RF's aspiration was to complete the Workgroup Report in December such that the Modification would be ready to proceed to consultation. A theoretical implementation date was suggested as April, but this may slip to May/June.
