1. Review of Minutes and Actions from previous meeting

1.1 Review of Minutes

2. Discussion

2.1 Action WG0503

FH provided a breakdown of the number of applications received based on the size, type and year requested. He confirmed that, having reviewed this, National Grid NTS still has concerns around the reduction in the minimum quantity to be eligible for the ad-hoc process. Volumes seen raised the possibility that the ad-hoc process could be relied on increasingly, and National grid NTS would regard this as neither desirable nor efficient.

TD asked if National Grid would be more comfortable with requesters being shippers only since the majority of activity was by DNs. FH agreed this would reduce the scale, although he did not think this was a feasible approach as he thought Ofgem would have concerns about discrimination – a key thrust of exit reform had been to ensure equal treatment of DN and other connections. FH also thought it likely that National Grid NTS would raise an alternative modification which retains the present volume limit.

TD advised that, given that no further clarification of the modification was required, he would prepare a draft report for the next meeting. FH confirmed that legal text had been requested and hoped to have this available by mid June.
