### 1. Review of Minutes and Actions from previous meeting(s)

## 1.1. Minutes

The Minutes from the meeting held on 06 July 2011 were accepted.

### 1.2. Review of actions from previous meetings

**WG0603:** Gazprom (SM) to ascertain views of ICOSS members regarding anonymity.

**Update:** SM had discussed this with ICOSS members. They failed to see any benefit and had no concerns. **Closed.** 

**WG0604:** All to provide feedback on the Mod 0378 and proposed reports, including anonymity.

**Update:** Comments were given during the meeting. GE suggested that if DW wanted to create greater rigour/control then the AQ related modifications needed to be packaged together. SL and KK indicated that they were considering raising alternative modifications, and DW responded that he was happy to amend his modification if that would help. KK would like to see what feeds into the calculations for AQ, and to see it covers information across the whole year. There was a brief discussion about read submission and data transparency, the Mod 81 reports and Ofgem review. DW reiterated that 0378 was raised to concentrate on the area of AQ Appeals, and LW explained which reports this modification was focused on. There was clearly scope for modifications to be raised on other areas, such as accuracy of allocation and transparency. As with any report, the limitations of its content and the interpretation to be applied needed taking into account and understanding. This modification enables parties to take an independent look at how to interpret.

LW mentioned that a Shipper had previously asked for LDZ SSP average AQs and offered to publish the data provided to all Shippers.

**WG0701:** British Gas (DW) to consider an additional report for the number of reconciliations up and down and Xoserve's ability to produce such a report.

**Update:** This had been considered but it was concluded that it was too complicated and DW will not include this in the modification. **Closed.** 

#### 2. Discussion

CW is to advise when legal text was available for review. A ROM had been requested, but the completion date was not yet available and LW was not yet in a position to grade it as Low, Medium or High impact.

LW believed that data items were held for the first two reports so this could be developed early next year; for the others, Xoserve did not currently collect data items so specific collection would have to be commenced and that therefore would not be available until next year.

BF concluded that there was not much concern about the modification, although SL and KK believed it could do more. Members confirmed that they would like to see the cost and the legal text before commencing completion of the Workgroup Report, and it was agreed to defer completion until the next meeting (15 August 2011).
