1. Introduction and Status Review

1.1. Minutes from the previous meeting

Minutes from the 06 June meeting were accepted.

1.2. Review of actions from previous meetings

WG0501: Revise modification to reflect comments/suggestions. **Action Update:** DW confirmed changes would be made. **Closed**

WG0502: Consider the materiality of risk based approach used by the BSC and report to Workgroup.

Action Update: DW had previously indicated his intent to amend the modification in order to introduce a threshold such that an audit will not occur for Shippers with small portfolios and their overall impact of AQ change on the market as a whole. Also see Action WG0602. **Closed.**

WG0601: Xoserve (LW, SP) to consider whether or not Xoserve can identify a means that might help to clarify the rough number of Shippers that might have breached the proposed 85% threshold had it applied historically.

Action Update: LW confirmed that a document had been provided on the T04 position for 2011. KK believed the tables indicated an improvement in performance with the information available. **Complete.**

WG0602: British Gas (DW) to consider defining (within 0379) a pre-audit process; appropriate triggers; and materiality to exclude the smallest players.

Action Update: DW aware of the need for business rules for a pre-audit process whereby the auditor would initially consider reported performance and be able to make a decision based on the process used by Shippers to determine if an audit is necessary and be able to ask questions to understand high performance. CW asked for views on the criteria for appointing an Auditor and whether this could be considered within the business rules. SM queried if there would be an appeals process. It was agreed to amend Action WG0602.

Amended Action WG0602: British Gas to produce a set of business rules to define a pre-audit process, consider an appeals process and the criteria for appointing an Auditor. **Carried Forward.**

WG0603: Scottish Power (KK) to consider defining (within 0379A) a pre-audit process; appropriate triggers; and materiality to exclude the smallest players. **Action Update:** KK acknowledged the need for business rules. It was agreed to amend Action WG0602.

Amended Action WG0603: Scottish Power to produce a set of business rules to define a pre-audit process, consider an appeals process and the criteria for appointing an Auditor.

Carried Forward.

WG0604: EDF Energy (SL) to define additional triggers for presentation at next meeting.

Action Update: Item deferred. Carried Forward.

WG0605: Scottish Power (KK) to consider (within 0379A) how obligations would be placed on Ofgem; and how supplier charges would be applied.

Action Update: Item deferred. Carried Forward.

WG0606: British Gas (DW) to discuss with National Grid Distribution (CW) defining liabilities and the flow of funds within 0379.

Action Update: It was recognised that the mechanism needs to be defined to reconcile any differences. The possible use of the RbD smear was considered. DW questioned if there was another mechanism to adjust. The Workgroup discussed if LSPs are within scope and if how to get monies back in the right place. **Carried Forward.**

2. Discussion

It was agreed that for the next meting British Gas and Scottish Power were to present a set of business rules, including the criteria for appointing an auditor and an appeals process.
