MA presented the amended modification and explained that changes had been made to the Solution in order to address inherent issues in the current UNC text The intent of the modification, as discussed previously, had not changed. No comments were received on the amendments made.

MA then explained the changes to the legal text that were required to avoid perpetuating the identified errors.

CR questioned the reference in 3.3.2(c) to 'Interruptible Supply Points' and RT questioned should DN Interruptible Supply Points exist in the current climate. It was noted that the concept of Interruptible Supply Points had been retained and that the definition has endured, and though it was not clear that this should be so it is not changed by this modification. Should the DNs wish to remove it then a further modification would be necessary; the DNs were considering the position.
