a) Modification 0565/0565A/0565B – Central Data Service Provider – General framework and obligations

AP suggested that the background presentation provided by National Grid NTS should be published alongside the DMR as it would be a useful guide for respondents. This was agreed.

RP would like to see clear views made in representations about preferences for the alternative solutions. LJ pointed out that the consultation template provides a question on preferences.

AL would like to seek views or concerns from respondents about the DSC and in particular if parties have identified reasons why they wouldn't sign on to the new arrangements. CWa felt this could send the wrong message to respondents. LJ advised that KPMG were in the process of communicating with UNC parties to make sure they were aware of the requirements of these modification, UNC and DSC arrangements prior to implementation and that this process shouldn't cut across the programme responsibilities.

AMa was concerned that the documentation is not listed in one folder on the modification page. LJ suggested it would be unworkable to list all of the documents on one page and listing by contract type would help respondents review each in order.

AL was concerned with the duration of consultation and suggested that it be increased. RP agreed with this view and suggested Panel review the Final Modification Report at short notice but leave enough time for review by the Joint Office and Panel.

• they should proceed to Consultation with a close out date of 08 December 2016 and that the Final Modification Report should be considered at short notice at 15 December meeting.
