1. Introduction

TD welcomed attendees to the meeting.

2. Consider Terms of Reference

TD summarised the Terms of Reference.

JC suggested that considering the accuracy of forecasting end-of-day linepack would assist the Review Group. National Grid NTS agreed to produce this analysis for the next meeting.

It was agreed that the Terms of Reference should consider interactions of any service with the National Grid Incentives. Ofgem was asked whether they agreed with National Grid's understanding of the licence definition of linepack, which would restrict the scope of development. DT added that the current Special Condition C27 definition excluded a tolerance service. Ofgem responded that it would not wish to exclude such a service and would consider reviewing the Special Condition C27 accordingly. The intention was for all viable options to be reviewed and Ofgem agreed to clarify at the next meeting its understanding of Condition C27 and the consequent scope for developing options.

It was agreed, pending clarification by Ofgem, the Terms of Reference should reflect the existing provisions of Condition C27. JC gained agreement that the Terms of Reference should specifically include charging implications. SL gained

agreement that the Terms of Reference should include interactions with Distribution Networks.

SL asked what transportation systems internationally the Review Group was likely to consider for comparison, and SP outlined those that National Grid NTS had in mind.

BW suggested that the reference to "cash-out fixed differential" was too restrictive and it was agreed that this should be replaced with a reference to "cash-out".
