# 1 Summary

### Is this a Self-Governance Modification?

Yes, we believe this is a Self-Governance Modification as this Modification will amend UNC TPD Section B in accordance with the legal text of Modification 0376S and reinstate those parts of Section B that were incorrectly overwritten through the implementation of 0376S. As such we believe that this modification does not introduce any changes to the UNC which have not already been implemented by the Authority via previous Modifications and therefore this Modification of itself:

- (i) is unlikely to have a material effect on:
  - (aa) existing or future gas consumers; and
  - (bb) competition in the shipping, transportation or supply of gas conveyed through pipes or any commercial activities connected with the shipping, transportation or supply of gas conveyed through pipes; and
  - (cc) the operation of one or more pipe-line system(s); and
  - (dd) matters relating to sustainable development, safety or security of supply, or the management of market or network emergencies; and
  - (ee) the uniform network code governance procedures or the network code modification procedures; and
- (ii) is unlikely to discriminate between different classes of parties to the uniform network code/relevant gas transporters, gas shippers or DN operators.

### Is this a Fast Track Self-Governance Modification?

Yes, we believe that this Modification qualifies as fast track self governance under b. below as it will correct errors arising from the process of incorporating the legal text from Modification 0376S into the UNC document rather than errors in the text itself. We consider therefore that this Modification:

- a. would meet the self-governance criteria; and
- is properly a housekeeping modification required as a result of some error or factual change, including but not limited to:
  - i. updating names or addresses listed in the uniform network code;
  - ii. correcting minor typographical errors;
  - iii. correcting formatting and consistency errors, such as paragraph numbering; or
  - iv. updating out of date references to other documents or paragraphs."

### Why Change?

This Modification will amend UNC TPD Section B in accordance with the legal text of Modification 0376S and reinstate those parts of Section B that were incorrectly overwritten through the implementation of 0376S, it will ensure that the text implemented via 0376S aligns with earlier changes to TPD Section B particularly the insertion of legal text for Modifications 0381 'Removal of the NTS Exit (Flat) Capacity "deemed application" process' and 0413S 'DN Adjustment of notices for the reduction of Enduring Annual NTS Exit (Flat) Capacity'.

# 2 Why Change?

This Modification will amend UNC TPD Section B in accordance with the legal text of Modification 0376S and reinstate those parts of Section B that were incorrectly overwritten by the implementation of 0376S, it will ensure that the text implemented via 0376S aligns with earlier changes to TPD Section B particularly the insertion of legal text for Modifications 0381 'Removal of the NTS Exit (Flat) Capacity "deemed application" process' and 0413S 'DN Adjustment of notices for the reduction of Enduring Annual NTS Exit (Flat) Capacity'.

This will require updates be made to UNC TPD Section B, paragraphs 3.2.3(a) (i) & (ii), 3.2.4 (iv), 3.2.8, 3.2.8(a), 3.2.8(a)(i) and 3.2.10(c).
