Xoserve Actions

At Distribution Workgroup on 27th August 2015, Xoserve took the following actions:

Action 0102: Xoserve (HC) to undertake data analysis regarding a suitable date start date for Ratchet charges to be commenced from.


Action 0103: Xoserve (HC) to investigate the most appropriate and suitable Option to be adopted.

Option 1 – Suppression of Ratchet Charges,

Option 2 - Adjustment of Ratchet Charges.



Proposed Solution



- Utilisation of existing processes
- For MPRNs which successfully meet the Modification 0551 criteria, the ratchet will occur, with the incentive charge being invoiced and payable as per the standard terms, with adjustment to follow
- The relevant SOQ increase will be maintained
- Shipper must submit query by D+5 (as per existing processes)
- Portfolio reports will be provided on a monthly basis to assist Shippers in identifying potential candidate MPRNs

Please note that the above process is illustrative only, and given the short timescales associated with its provision, has not necessarily been prepared in line with formal process modelling conventions.



Terms and Definitions

Xoserve have provided proposed Business Rules, in line with the proposed solution which has been developed.

For the purposes of this presentation, the following terms are utilised with the below definitions:

BSSOQ	Bottom Stop Supply Point Capacity	



Proposed Business Rules Review

BR1:

- A Candidate MPRN is any DM Supply Meter Point which comprised part of an aggregated configuration as at X date <u>and</u> which was subsequently disaggregated under UNC Mod 0428 requirements and remained as DM.
- Excludes any SMP confirmed as DM after X date which did not previously comprise part of an aggregated configuration.
- Applicable to Winter 2015/2016 only
- NDMs are excluded

BR2:

- Candidate MPRNs will be subject to two tests, both measured using the combined UDQO of the disaggregated DM SMPs:
 - Against the previously registered aggregated SOQ, and
 - Against the combined registered SOQ of the newly disaggregated SMPs.
- If the combined UDQO is lower than the greater of the two figures, relief from the ratchet incentive charge will be provided.

BR3:

 Relief from ratchets will constitute exemption (through retrospective adjustment) of the ratchet incentive charge, but the consequent SOQ increase will be retained.

Proposed Business Rules Review - cont.

BR4 & 5:

- Ratchets will continue to be applied on an individual SMP basis, as per existing processes.
- Shippers must raise a query with Xoserve upon receipt of the ratchet notification in order to be eligible for relief.

BR6:

 Relief from ratchets will not be provided if the combined UDQO exceeds the values defined in BR2.

BR7:

- Any SOQ reductions will cease the MPRN from being a candidate for relief.
- All MPRNs in single Shipper ownership all excluded
- MPRNs owned by different Shippers only reductions applicable to an MPRN within a given Shipper's ownership will trigger exclusion from relief.

BR8:

 Relief from ratchets is only provided for a period of 30 business days following notification of the first ratchet, following which Modification 0551 rules will not apply to the same MPRN.

- Ongoing costs on a transactional basis based on queries submitted, irrespective of outcome?
