51.4 Consider Variation Requests.

a) Proposal 0163 "Offering Capacity at Donor ASEP in Trades & Transfers Process"

Following a brief presentation by S Gordon (ScottishPower) and a discussion, the Panel did not determine that the Variation Request was immaterial, with no votes cast in favour. Therefore, Modification Proposal 0163 was deemed withdrawn and replaced by Modification Proposal 0163V "Offering Capacity at Donor ASEP in Trades & Transfers Process".

Panel Members discussed at length their concerns surrounding the Modification Proposal, reiterating their beliefs that the variation, as presented, represents a material change and that further development of the Proposal is required.

Members went on to suggest that perhaps a more appropriate process approach would be to withdraw the Proposal and replace it with a new Urgent Modification Proposal (including the legal text that is currently being drafted). Furthermore, Members indicated their willingness to support the Proposer in developing the new Urgent Modification Proposal to ensure that all concerns are addressed.

The Chairman summarised the discussion thus. A new Urgent Modification Proposal will be raised by ScottishPower in draft form for a quick review prior to formal submission to Ofgem for a decision on urgency. He also pointed out that it is up to ScottishPower to consider formally withdrawing 0163V in due course. D Edward observed that if 0163V is not withdrawn, Ofgem would have to make a decision about it as part of the UNC governance process.
