  Following a presentation from C Sykes (E.ON UK), the Panel failed to make a determination that the Proposal should proceed to Consultation, and hence it was referred to the Governance Workstream The following Members cast votes in favour of the Proposal proceeding to consultation: C Sykes (E.ON UK), P Broom (Gaz de France), M Young (BGT) and S Ladle (Total Gas and Power) who also cast a proxy vote for R Cross (Statoil)
- c) Proposal 0065 'Amend the BNFA Neutrality Interest Rate'
  Following a presentation from R Hewitt (National Grid NTS), the Panel voted
  UNANIMOUSLY for the Proposal to proceed to consultation.
  The Panel also voted UNANIMOUSLY to approve C Thorneywork as Subject
  Matter Expert to write the Modification Report.
- d) Proposal 0066 'Programmed Maintenance Notice Periods at NTS System Exit Points'
  Following a presentation from C Sykes (E.ON UK) on behalf of the Proposer, the Panel voted UNANIMOUSLY for the Proposal to proceed to consultation. The Panel also voted UNANIMOUSLY to approve D Hawkin as Subject Matter Expert to write the Modification Report.

### 17.11 Consideration of Final Modification Reports.

a) Proposal 0052 'Storage Withdrawal Curtailment Trade Arrangements in an Emergency'

Panel Members considered the report was in the correct form and discussed whether or not to recommend implementation of the Proposal.

Most Panel Members considered that implementation of this Modification Proposal could be expected to further the GT Licence 'code relevant objectives' of 'the promotion of efficient and economic operation of the pipeline system' and 'facilitating effective competition between relevant Shippers' and voted by Panel Majority to recommend implementation of the Proposal.

The following Members cast votes: C Sykes (E.ON UK), P Broom (Gaz de France), S Ladle (Total Gas and Power) who also cast a proxy vote for R Cross (Statoil), M Young (BGT), B Grubb (Scotia Gas Networks), R Cameron Higgs (Northern Gas Networks) who also cast a proxy vote for L Spierling (Wales and West Utilities) and A Raper (National Grid UKD).

The Panel may also discuss the Workstream report on Proposals 54, "Emergency Curtailment Quantity (ECQ) Methodology Statement", and 54a "Modification to Codify Emergency Curtailment Quantity (ECQ) Methodology". In addition, a number of Proposals regarding Uniform Network Code Governance may be considered if the Workstream reports are available.
