NB There followed a general Panel discussion. regarding process and timetabling issues for the recent Urgent Modification Proposals relating to cash out and capacity auctions. Concern was expressed that timescales for consultation had been very short for what are very important issues, especially when they are not new and have been known about for some time.

There was also concern that the Long Term Capacity regime could be undermined by such uncertainty.

Following consideration of the Workstream report, the Panel voted UNANIMOUSLY for the proposal to proceed to consultation. The Panel voted also UNANIMOUSLY to approve L McGoldrick as Subject Matter Expert to write the Modification Reports.

- 11.13a) There was a discussion around the timing and business content of extraordinary Panel Meetings and it was agreed that as a general rule they should be kept solely for the consideration of Final Modification Reports and the making of recommendations for implementation.
