# 45. 4 Consider Final Modification Reports.

a) Proposal 0138 "Transitional Arrangements for Entry Capacity Transfers to Sold Out ASEPs"

Panel Members considered the report was in the correct form and discussed whether or not to recommend implementation of the Proposal.

The Panel was divided as to whether implementation of this Proposal would further the relevant objectives. The Proposer considered that by helping to optimise the allocation of entry capacity implementation of this Proposal could be expected to further the GT Licence 'code relevant objectives' *"the efficient and economic operation of the pipeline system"* and *"the securing of effective competition between relevant shippers"*, whereas others considered that the complexities and uncertainties, coupled with unintended adverse incentives, meant it would not. Members agreed Implementation could facilitate meeting new Licence obligations on National Grid NTS to facilitate the transfer of sold capacity between ASEPs. National Grid NTS expressed concern about the practicalities of implementing the Proposal, and felt this meant implementation would not be consistent with its Licence obligations and would not further *"the efficient administration of the Uniform Network Code"* relevant objective.

The Panel then failed to recommend implementation of the Proposal, with three votes cast in favour (C Wright, R Fairholme also proxy vote for P Broom).
