**The following new Topic was created:**

**009OF Flow Weighted Calorific Value**

A presentation was given by National Grid NTS proposing that current arrangements for the service would continue. This was agreed and, arising from this, it was also agreed that a review be conducted on Section F of the OAD.

**The following existing Topics were reviewed:**

**007OF Gas Transporter Co-operation on Planning and Investment in Networks**

A presentation was given by Wales and West Utilities on the 2007 Bookings timeline that emphasised the congestion that would occur if Modification Proposal 0116V were implemented. Various actions were taken in order to evaluate solutions.

**001OF NTS Exit Capacity Reform**

It was agreed that a walk-through of the legal text of Modification 0116V would be useful. National Grid NTS has since responded that it would wish to wait for the current Competition Commission Appeal to conclude before agreeing to participate.
