Matters for Panel's Attention

The Workstream invited the Panel to endorse the following statement:

"The Offtake Arrangements Workstream will provide an open forum under the Chairman's Guidelines to primarily address inter-transporter Topics that might result in changes to the UNC."

Modifications Activity

Draft Modification Reports Submitted:

- 645 'Provision of Available Interruption Information' *Reps close-out 12/09/05* The Proposer was given the opportunity of outlining this Proposal and some discussion took place on simple implementation options that would be in place for the 2005/6 and subsequent winters.
- 646 'Extension of the Sunset Clauses for Registration of Capacity at NTS Exit Points' *Reps close-out 12/09/05* 7 The Proposer was given the opportunity of outlining this Proposal. The ensuing discussion highlighted the interactions between this Proposal, Advanced Reservation of Capacity Agreements (ARCAs), the IExCR and SC4B statements, each of which are the subject of consultation processes.

Topics Activity

The following New Topics were created:

006OF Role of Offtake Committee

In discussions on Modification Proposal 045, it emerged that implementation may require changes to Offtake Subsidiary Documents and/or agreement on other matters. A review of the scope of the Offtake Committee, as presently defined in the UNC was, therefore, needed to ensure that any such consequential changes would be addressed.

007OF Gas transporter cooperation on planning and investment in networks

The potential need was identified for a review of the end-to-end process of inter-transporter network planning, including lead-times, in terms of adequacy and suitability of UNC provisions.

The following were reviewed:

001OF NTS Exit Capacity Reform

This was discussed in terms of Modification Proposal 046 and related documents (see above)

004OF CV Data for Network Planning

A potential need for provisions within the Offtake Communications Document to ensure standard treatment of CV data was identified.

005OF NTS-LDZ Operational Information for Low Demand Days

The need for a UNC Proposal was identified to reflect the requirement of even gas flows on an LDZ basis, as opposed to a flow requirement applied to each individual offtake.
