On 19 July 2016, Ofgem issued a notice under Part B of Special Condition 4A of the Gas Transmission Licence to propose to modify the GT1 Price Control Financial Model (PCFM). This is the version of the model we intend to use for the Annual Iteration Process (AIP) which will take place by the 30 November 2016. National Grid sale of Gas Distribution Network business – decision on regulatory aspects and the transfer of assets and statutory consultations under section 8AA and section 23 of the Gas Act 1986. On 10 November 2015, National Grid announced its intention to sell a majority stake in its gas distribution network business. On 23 June 2016, National Grid Gas plc (NGG) requested permission to transfer its gas distribution transportation assets from NGG to a new subsidiary company (NewCo). In May 2016, we published a consultation

which described our role in the sale process and sought stakeholder views on issues arising from these potential transfers.
