Consultation on the mid-period review of RIIO-T1. On 18<sup>th</sup> August 2016 Ofgem opened a consultation on our decision to launch an Mid-Period Review for the RIIO-T1 price control focusing on three areas, all of which relate to National Grid's outputs (both gas and electricity transmission). We are seeking views on our proposals for changes to outputs and allowances in each of these areas. The deadline for responses to this consultation is Thursday 6 October 2016. We will publish our decision on the MPR in November or December after we have considered responses to this consultation. We intend to implement any changes to allowances through modifying the licence, including the Price Control Financial Model (PCFM) in 2017 so that revenue changes can take effect from 1 April 2018.
