Industry update from Ofgem – Up to date as of 5th July 2016

Brexit - No immediate change in terms of how the GB energy markets work with Europe. Ofgem will continue to participate in EU institutions and single European energy market as requested and required pending any further decisions made by the UK Government.

Tariff and CAM NC Comitology. Ofgem accompanied DECC to the June 29th and 30th formal meetings of the Gas Committee. The resulting text was largely unchanged from the versions circulated in mid-June. DECC are continuing to engage with the EC.

Gas Quality Code Amendment Update. The ENTSOG consultation requesting views on proposals to amend the Interoperability Network Code is still open and closes on 15 July 2016. We encourage you to respond. Ofgem will be responding and are in the process in finalising our submission. Our view is largely aligned with that of National Grid and we focus on issues around the following themes, scope of implementation, implementation timing, application, A-deviations, allowance for off-spec gas, and flexible limits, as they relate to the impact on industry; implementation costs and ultimately the cost to the consumer. Feedback from ENTSOG's workshop in April is for more workshops and there will be 2 more this year on 13 September and 16 November.

Updates on Project Nexus. On 30th June 2016, Ofgem published a decision that they intend to continue with a programmed delay to move implementation date of Project Nexus to between 1st February and 1st April 2017. Open letter on proposed changes to the Ofgem Licence fee principles document. On 30th June 2016, Ofgem published a letter setting out our proposals to amend the Ofgem licence fee principles document (the LFPD) following our entering into a new cost control framework. A key change is an agreement with government to replace Ofgem's RPI-x cost control regime with a five year framework, to take our total expenditure down from £89.5m in 2015-16 to £82.0m in 2019-20, representing a reduction in real terms of 15%. Modification of National Grid Gas' transporter licence to add three new exit points to the National Transmission System. On 17th June 2016, we published a notification of our intent to modify Part F of Special Condition 5G of National Grid Gas plc's transporter licence as proposed in our section 23 notice published on 18 March 2016. The changes add three new exit points to the licence and designate "St Fergus Segal" as a relevant exit point as required by the EU Gas Regulation 715/2009. It also designates "Palm Paper" as a non-relevant "Industrial" exit point and "Kinneil CHP" as a non-relevant 'Power Station' exit point. The changes take effect from 15 August 2016.
