

Performance Assurance Workgroup

Response to actions from the 24th March 2015 meeting

0301: *Reference estimated reads* - Xoserve (AM) to provide an example of when estimates are calculated on a continual basis along with reads for DM sites that would potentially identify the level of estimated reads involved.

0302: *Reference estimated reads* - Xoserve (AM) to look to identify a couple of suitable example sites and provide an assessment v's actual estimated reads to try to help to understand the requirements better.

This short paper is a written version of the material presented at the 8th April Workgroup meeting .

The table below is the results for a sub-set of shippers with a daily read population. The table is based upon the requirements specified in the Guidelines document Performance Assurance Reporting Template Guidance Document dated 22nd March 2015.

This table meets the requirements of action 301. The table sets out by Shipper the number of daily reads required in the period, the number of days that an estimate was used and the number of days for which actual reads were provided.

It is not currently possible to provide a response to action 0302. This action requires individual review of read and estimate submissions and then the actual energy between actuals with estimates in between. The information can be obtained, but resource constraints presently prevent this exercise from being undertaken. The workgroup agreed that this action could be closed as there was no apparent benefit to it.
