### **Inter-Shipper MOD640 Charge Reallocation**

- Discussions have indicated that Transporters could be responsible for the re-allocation of MOD640 charges
- xoserve have questions that require further discussion
  - To aid a request for ROM / Rules Analysis
- Key questions in principles regarding:
  - Submission of inter-Shipper reallocation requests
  - Multiple Shipper requests (>2 Shippers)
- Proposals could include multiple Shippers in charge reallocation process
  - 2008/09 Gas Year up to 4 Shippers were involved
  - This needs to be considered in any request



### Inter-Shipper MOD640 Charge Reallocation Discussion

- If Shipper submits request to xoserve for re-apportionment of charges
  - Does one Shipper submit this request or all Shippers?
    - If one Shipper how would other Shippers be aware that the request is submitted, progressing, rejected, completed?
    - If >1 Shipper timing requirements for receipt of requests
    - Warrants 1 Shipper or all Shippers?
  - Is a request required from each Shipper involved but 'linked'?
    - 'Linking' queries adds complexity to any solution
  - Multiple (>2) Shippers allocated charges does any reallocation have to involve all involved Shippers or just some?
    - If agreement not reached across all Shippers, can only 2 Shippers submit a request?



#### Inter-Shipper MOD640 Charge Reallocation Discussion

- Shipper request for reallocation of charges based on:
  - Financial value to be reallocated between Shippers
  - Percentage of total MOD640 invoice reallocated
    - If not across all Shippers involved how would this be managed?
    - x% of total charge or charge between Shippers raising reallocation request?
  - Should requests be validated against the original MOD640 charge?
- If any element of the data is incorrect xoserve would have to reject
  - e.g. reallocation does not add up to 100% or total financial value
- Timings if all Shippers involved have to submit queries at same time with corresponding data
  - If one Shipper does not submit or inaccurate, reject all?
  - Is there are requirement to chase, notify or manage progression of requests?
