Rolling Monthly Transfer and Trade of System Entry Capacity

Invitation to participate in the
Rolling Monthly (Trade Initiation) Surrender Process (RMTISSEC)
for Capacity period October 2015

Pursuant to TPD Section B2.3.3 of the Uniform Network Code, National Grid Gas plc invites you to take part in the rolling monthly trade initiation process for the surrender of capacity for October 2015.

The Surrender process will be conducted within Gemini in accordance with the Transfer and Trading Surrender Tender Rules (Terms and Conditions). For your convenience a copy of the Terms and Conditions are attached to this letter in Appendix B. The Terms and Conditions must be accepted within Gemini before rolling monthly surrender offers can be made.

National Grid NTS will conduct the surrender process on the following date:

Thursday 3rd September 2015

The surrender window will commence at 08:00 and close at 17:00 on the same calendar day. A rolling monthly surrender offer may be withdrawn or amended until, but not after 17:00 on that day. Users may submit up to a maximum of two rolling monthly surrender offers per ASEP.

Users are invited to submit Surrender offers in kWh/day (but not for a quantity less than 100,000 kWh/day) up to an aggregate amount not exceeding their Firm NTS Entry Capacity entitlement at the ASEP for the capacity month of **October 2015**, and each surrender offer should specify the minimum price (rolling monthly Surrender price) the User wishes to be paid in respect of the surrender of Firm NTS Entry Capacity at the ASEP. For reference the reserve prices for the RMTNTSEC auction are attached in appendix A.

The Tender will be conducted in Gemini and Surrender offers should be made using the **Deal>Capture>Create Bids** screen and selecting **RMTISSEC** as the Method of Sale. If you wish to check your entitlements prior to submitting a surrender offer you should navigate to **Home > Product > Entitlements - Net > Query**

Rolling monthly Surrender offers will be accepted or rejected after the RMTNTSEC auction bid window has closed. National Grid NTS may accept all or part of any surrender amount and Users will be informed of the quantity of any Surrender Amount that has been allocated following completion of the Rolling Monthly Transfer & Trade System Entry Capacity ("RMTNTSEC") process.

National Grid NTS will issue an invitation to participate in the RMTNTSEC auction not less than five (5) business days in advance of the auction date.

Please note, following the implementation of Modification 501V (Treatment of Existing Entry Capacity Rights at the Bacton ASEP to comply with EU Capacity Regulations):

- the September 2015 RMTISSEC auction (covering NTS Entry Capacity Trade and Transfer for October 2015) will be the final RMTISSEC at the existing Bacton ASEP.
- for clarity, there will be no RMTISSEC auction held in October 2015 (covering NTS Entry Capacity Trade and Transfer for November 2015) at the existing Bacton ASEP
- the November 2015 RMTISSEC auction (covering NTS Entry Capacity Trade and Transfer for December 2015) will be the first RMTISSEC in which the Bacton UKCS ASEP will be included.
