## Please summarise (in one paragraph) the key reason(s) for your support/opposition.

NTS users have for some time expressed concern at the apparent absence of a robust process to ensure certainty and consistency in the treatment of requests to connect either a supply or a load to the NTS. It seems likely that this resulting uncertainty may have caused potential connecting parties to suffer cost and time overruns on projects. This proposal seeks to deliver much greater certainty around the costs and timings of a connection application, and in doing so will streamline the connection process to the benefit of network users. The formal governance proposed will provide greater certainty over expectations to both potential connecting parties and National Grid;

- Implicit recognition that efficient delivery of the physical connection, or upgrade to an existing connection, is equally important to the obtaining of system capacity;
- With governance comes greater transparency of the process and greater confidence that it will be applied appropriately and in a non-discriminatory manner;
- National Grid will have greater incentives to meet customer requirements in an efficient manner;
- A more transparent and accountable connection process will facilitate competition in supply as the NTS is developed more efficiently when accommodating new gas system entry, exit and storage points;
- The proposal paves the way for the industry to consider a more integrated approach to delivering physical connections and system capacity.
