# Please summarise (in one paragraph) the key reason(s) for your support/opposition.

EDF Energy opposes implementation of UNC 0507 which seeks to delay or prevent the implementation of UNC 0451AV. The proposer has not provided any evidence or analysis that demonstrates that UNC 0507 will better the Relevant Objectives. Whilst it would have been preferable for the pre-payment profile to have been in place when UNC 0451AV was implemented in February 2014; all industry participants were made aware that a pre-payment profile would be developed and it was understood that invoices would apply from that date once the profile was agreed.

Evidence that has been provided to DESC indicates that pre payment meters in EUC1 may have a different profile to other EUC1 customers. The profile of a prepayment customer is flatter than that of a standard domestic credit meter customer which effectively results in an over allocation of gas during the winter period and under allocation of gas during the summer period for this sector of the market. Therefore if the current profile creates a cross subsidy in allocation between credit and pre payment customers, this situation should be rectified at the earliest date.

Significant time has been spent in industry workgroups developing the profile and at the very least UNC 0507 will reduce the period of correction, in the worst case scenario where implementation of UNC 0507 is after 1<sup>st</sup> January 2015 the industry will not receive any benefits whilst incurring significant sunk costs.
