We strongly believe that Unidentified Gas should be allocated fairly and equitably, based on throughput, where there is no evidence to allow allocation elsewhere.

Modification Panel Members have indicated that it would be particularly helpful if the following questions could be addressed in responses:

Q1: Please provide as much information and analysis to support your response, particularly any justification for why any particular class should, or should not, attract unidentified gas costs.

We believe that all classes should attract unidentified gas costs; each class potentially has different types of issues that can contribute to unidentified gas volume. No class should be excluded or disproportionately included; we believe that 0473A delivers a fair and equitable method of unidentified gas allocation.

**Q2:** We welcome views on the attribution of unidentified gas costs under these modifications to NTS direct-connected sites.
