Please summarise (in one paragraph) the key reason(s) for your support/opposition.

We strongly **oppose** implementation of mod 0473 with its intent to exclude Class 2 sites being allocated any UG cost. This mod opens a gateway for suppliers to opt out of UG allocation through a 'safe haven', resulting in the disproportioning and redirecting of UG costs to SSPs that are not able to provide reads daily. **Mod 0473a** proposes a more appropriate and accurate allocation of costs between Shippers and Suppliers as well as secures effective competition between Users.

Modification Panel Members have indicated that it would be particularly helpful if the following questions could be addressed in responses:

*Q1:* Please provide as much information and analysis to support your response, particularly any justification for why any particular class should, or should not, attract unidentified gas costs.

Unidentified Gas is an industry wide issue affecting all Classes. Not allocating UG to any certain Class grossly distorts competition and creates inaccuracies in the allocation of UG costs between Users.

*Q2:* We welcome views on the attribution of unidentified gas costs under these modifications to NTS direct-connected sites.
