Thank you for your invitation seeking representation with respect to the above Modification Proposal which National Grid Gas Distribution (NGD) would like to support.

Do you support or oppose implementation?

Support.

Please summarise the key reason(s) for your support.

NGD concurs with the proposer that the provision of more frequent (monthly) historic Meter Information and Meter Reading history to Users would lead to quicker and more timely resolution of data discrepancies and therefore ultimately assist with the AQ review.

We also agree that timely availability to incoming Users of Meter Reading history and Meter Information provides a 'level playing field' concerning data transparency and would therefore remove any current inequity.

- (i) between relevant shippers;
- (ii) between relevant suppliers;
