National Grid Transmission supports the implementation of Modification Proposal 0406S "Changes to the Measurement Provisions of the px (TGPP) Limited Network Entry Agreement (NEA)". We therefore support the Modification Panel's decision that this should be a self-governance modification.

National Grid Transmission supports the proposer's view that the implementation of Modification Proposal 0406S would better facilitate the securing of effective competition between relevant shippers within the UK. Proposal 0406S will facilitate an increased supply of gas into the UK and will, when flowing, offer an additional source of gas for the UK thus increasing competition among relevant shippers.
