As proposer, National Grid NTS believe that the change proposed in Modification 0413S is needed to remove a provision in the code which may unnecessarily restrict DNO Users from reasonably adjusting Enduring Annual NTS Exit (Flat) Capacity reduction requests for Gas Years Y+1, Y+2 and/or Y+3. Implementation of this modification may enable DNO Users opportunity for more economic operation and may enable National Grid NTS to make better informed operational planning and investment decisions and reduce the risk of some sterilised NTS Exit Capacity.
