Summary of key reasons:

This modification is proposing to amend the UNC so that it allows end users/shippers who wish to have a new supply point the facility to connect as an interruptible customer. This will allow them to benefit from the interruptible sites process.

We believe these amendments would be a positive change from the existing process where end users/shippers have to wait for the investment to be completed and will consequently benefit customers and their businesses. By proposing a zero charge there will be no discrimination against existing end users/shippers therefore not violating Relevant Objective A11.1(d), the securing of effective competition.
