#### **Minutes**

#### 1. Introductions

SC welcomed the group and introductions were carried out. SC went on to present the agenda items.

#### 2. Actions from Previous Meetings

SC ran through all previous actions. (See updates above)

#### 3. Stats and Unregistered Reports

SC presented the industry statistics. (See Meeting Slides).

SC also presented a proposed new format which would include data fields to show the number of S&U MPRNs that are under investigation by Shippers. (See Meeting Slides).

#### 4. End User Letter Exercise Update

MES gave a summary of the work conducted on the End User Letter exercise and went on to present some analysis on the responses received from End Users and returns by Royal Mail; and the confirmation Status and Meter Point status of the MPRNs selected in the sample.

It was noted by NW that there was a significantly larger pot in the time span between 2005 – 2009, and this appeared to be partly due to the property crash, and developments not going ahead.

DA presented a case history of an MPRN which was included in the sample. This illustrated that investigation into S&U records can not be limited to issuing end user letters and would require an element of desktop and physical investigation, requiring local knowledge.

# 5. Response to Ofgem's Open Letter to Gas Distribution Networks (GDNs) on Tackling Unregistered Sites

EM (on behalf of all GDNs) presented the proposed plan of action to address the existing population of Shipperless and Unregistered sites. (See Appendix 1). The "Plan" includes an element of data cleansing by Shippers, UIPs and GDNs which should be completed before the End User lettering element. The GDNs have raised a change order to engage Xoserve conduct the required activities. The first dataset will be issued to relevant parties by w.e. 10/11/13.

The plan was met with general approval by the Workgroup.

DA said that work was required on the detail of the plan. In particular what would the data cleansing work consist of; the wording of the End User letter would need to be agreed and the number of End User letters would have to be decided (1 letter or 2) and also if there would be a phased release of the population. DA also emphasized that sign-on was required by all parties.

### Action 156 – GDNs to engage with Xoserve to finalize the details of the "Plan"

#### 6. MPRNs set to DE in Error

DW presented several issues that Gazprom had encountered surrounding MP Status changes following service removals by the GDNs.

The issues included:

- GDNs not setting the MP Staus to DE following a service removal
- GDNs issuing correspondence to End Users and Gazprom regarding service removals with incorrect data

DW also questioned the scenarios when an MPRN would be created for a service. NW responded to DWs concerns. He had responded to all examples previously submitted to him. The group discussed the MPRN Creation scenarios and agreed that they were correct as presented. (See meeting Slides)

#### 7. GDN Updates

LW gave a presentation on the work that SGN had conducted to reduce the number of MPRNs reaching the anniversary of their creation without a confirmation or being set to DE or EX. (See Appendix 2)

ARS gave a presentation on the work that NGN had conducted in the investigation and resolution of existing S&U MPRNs. (See Appendix 3)

DM gave a presentation on the measures that GDNs had put in place to address the root causes of S&U MPRNs. (See Appendix 4)
